2. Applications for Membership of Decom North Sea will be subject to approval by the Board of Directors or other such Membership group as the Board approves. Decom North Sea reserves the right to refuse Membership to any applicant and is not obliged to disclose the reasons for refusal.
3. Decom North Sea reserves the right to modify or alter the Membership fees and benefit structure at any time. The receipt of a completed Membership application form does not constitute a formal offer or contract of Membership, until such application is approved by the Board of Directors.
4. Organisation size is based upon the number of employees. Where an organisation is a wholly owned subsidiary or part of a group of companies, the organisation size is taken as the total employee numbers for the group.
5. Where a Member changes category by nature of size during any annual Membership period, that Member will be required to change its Membership status only at the beginning of the next annual Membership period.
6. Decom North Sea reserves the right to refuse renewal of Membership at any time to a Member who:
 - **fails to pay by the required time any fees due, either for annual subscription or for any event, publication or other service provided by Decom North Sea; and/or**
 - **misrepresents Decom North Sea, brings Decom North Sea into disrepute or acts in any manner deemed inappropriate by the Decom North Sea Board of Directors.**
7. Joining Decom North Sea as a Member does not imply endorsement of any kind by Decom North Sea. Members may not at any time use Decom North Sea Membership in promotional activities or to endorse any activity or product without prior written consent.
8. By joining Decom North Sea as a Member, the Member agrees to grant a guarantee to pay the sum of £1 in respect of any outstanding obligations of Decom North Sea on the winding up or dissolution of Decom North Sea, such sum to be due and payable on winding up or dissolution.
9. As Decom North Sea is based on consensus from all Members, Decom North Sea does not guarantee to represent the individual interests of any company or organisation at any time.
10. The Members' benefits as set out in the application form are indicative only and Decom North Sea does not guarantee to provide all benefits at all times and reserves the right to change the benefit structure from time to time as decided by the Board of Directors.
11. Members will be invoiced annually for Membership of Decom North Sea. If a Member does not wish to renew their subscription for the relevant year then they will be required to advise Decom North Sea of this in writing within 30 days of the annual subscription invoice being sent to the Member, failing which they will be obliged to pay the annual subscription fee in accordance with Condition.
